Webb Industries’ obligation under this Warranty is limited to the repair or replacement of the product without charge at an authorized Webb Industries dealer or at the factory of Webb Industries in Johannesburg, when the product is returned to an authorized dealer or to the factory with all transportation charges prepaid and examination of the product shall disclose it to have been defective in the respects aforesaid during the Warranty Period.

The Warranty Period shall not be extended beyond its original term with respect to any part or parts repaired or replaced by Webb Industries hereunder.

This Warranty Period shall not apply to any product which has been repaired or altered in any manner by anyone other than Webb Industries, or if the defect, malfunction or failure of the product to conform to this Warranty was caused by damage (not resulting from defect or malfunction) while in the possession of the consumer, or from unreasonable use, or from improper installation or application, or to any product which has not been maintained or used in accordance with the operation specifications set forth in Webb Industries’ written instructions.
